To meet regulatory requirements, drivers must score at least 80% to pass the ELDT test, while organizations must maintain proper documentation to support compliance with Department of Transportation (DOT) and Federal Motor Carrier Safety Administration (FMCSA) regulations. The absence of a robust and reliable tracking system created operational inefficiencies and compliance risks for the organization.

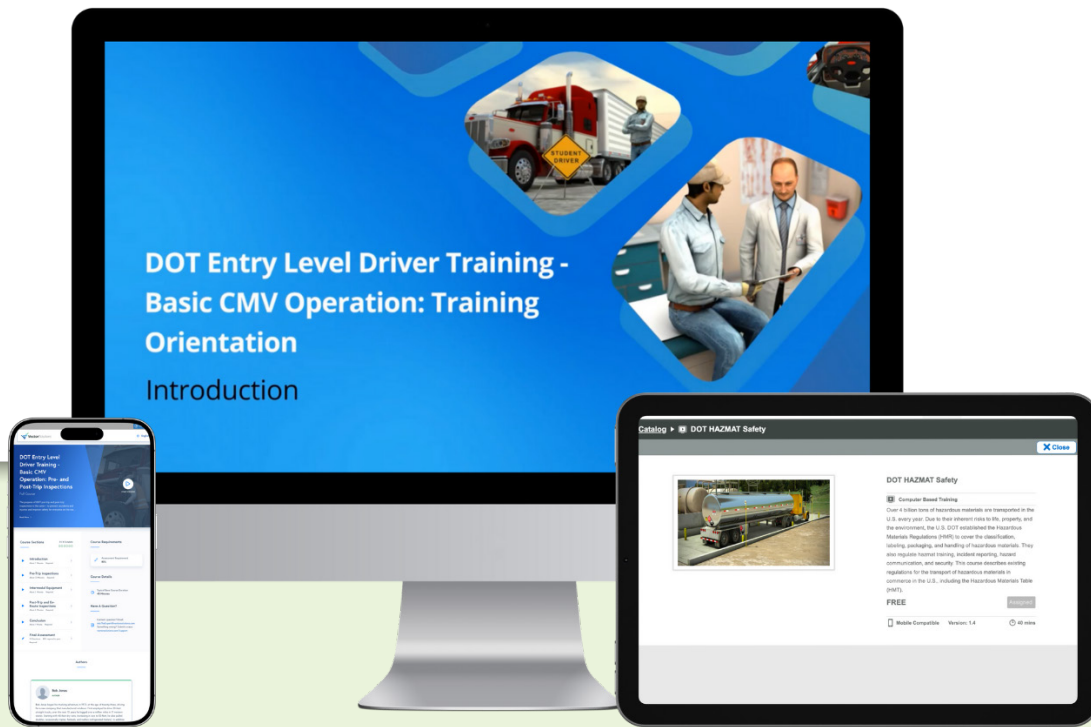
