

# West Virginia Law Enforcement Officer Training

The West Virginia Law Enforcement Professional Standards (LEPS) mandates 16 hours of training for West Virginia law enforcement officers, annually due by June 30. Of those hours, 25% may be completed via online training. LEPS requires courses to be pre-approved and does accept courses certified by the International Association of Directors of Law Enforcement Standards and Training (IADLEST) as part of the National Certification Program (NCP).
