

# TargetSolutions Quarterly Sunset Guide (Canada)

**Q3 2026 Sunset Date: July 15, 2026**

We perform quarterly catalog maintenance to remove older course versions that no longer meet our standards, helping to keep personnel prepared and compliant with access to the most up-to-date training.

Please review this guide, which details courses that will be retired by catalog, available replacement courses, and FAQs. **The FAQs outline important information and actions system admins may need to take before the sunset date to avoid disruption.**

## FAQs

**Q: When a course is retired will it still appear in my course library?**

A: After the date of the retirement, the course will no longer appear in your library.

**Q: When a course is retired will it still appear in “My History” and completion reports?**

A: Yes. Learners will not be able to access the course anymore, but they will still see the record in “My History”.

**Q: Will learners still be able to access their Certificate of Completion for retired courses?**

A: Yes. The certificate of completion will still be accessible for all courses being retired in “My History”.

**Q: What will happen to pending assignments?**

A: They will be removed. Administrators may want to send a reminder to users with pending assignments.

**Q: What will happen to the credentials that have these courses?**

A: **CERTIFIED CREDENTIALS:**

- Any course that was deactivated during the retirement process will appear greyed out and noted as “Archived/Sunset” in the Certified Credential.
- The course will no longer appear in the available training section of the credential topics for learners.
- Completed courses will still contribute towards the credential total completion progress.
- Completed courses will still appear in the completions section for the learner.

A: **CUSTOM CREDENTIALS:**

- It will be up to the site administrator make updates to their custom credential requirements. It is recommended to leave the courses to be sunset in the credential or completion progress will be affected (see example). The site administrator will only need to add any replacement courses into the credential. If the changes are not made you will see a “phantom” course in the credential and users may not be able to meet the requirements for that credential.



- Any course that was deactivated during the retirement process that is in a custom credential will appear greyed out and noted as “Sunset by Vector Solutions” in the Manage Credentials tab accessible by Site Administrators.
- The course will no longer appear in the available training section of the credential topics for learners.
- Completed courses will still contribute towards the custom credential total completion progress. **NOTE:** Removing sunset courses from the credential will affect the learner’s progress.
- Completed courses will still appear in the completions section for the learner.

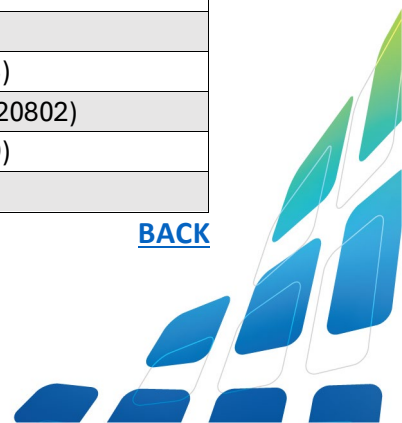
