



# Acadis Use Across Multiple Academies and User Profiles

## Using Acadis to Ensure Users Have Access Only to the Data They Should

Acadis is often used to manage training and compliance data for multiple academies across a broad user community. Accordingly, Acadis has several features designed to manage data access so that users can securely and confidently work with only the information they have permissions for.

**User Roles** in Acadis determine what specific actions a user can perform in Acadis. Users can have multiple User Roles, when needed, to support even the most complex business use cases. Custom roles can be created by Acadis Administrators and assigned to an individual's User Account.

**Data Partitioning** allows administrators to restrict the data Acadis users can see and use. This capability is essential when Acadis is used to track sensitive data for multiple organizations. Data partitioning can be enabled by Acadis administrators and individual data access assigned on the Acadis user's User Record.

**Academy Licenses** are used to allow an Organization Record to become an owner of the training materials, curriculum, tests, certifications, and much more for the training academy. Acadis supports the ability to create a multi-academy/multi-tenant environment, allowing separate training entities to create and maintain their own, distinct training and compliance business artifacts and processes. When used with Data Partitioning, Acadis administrators can provide specific data access and functional capabilities for each user, ensuring they are able to work with only the training, compliance, and personnel information that align with their business or position.

# Examples


## User Roles

Organization Z is a large agency with several separate branches that support various elements of the training and compliance ecosystem. Instructor duties are managed by an Operations Group, but class schedules are managed by the Administration Group.

Unique User Roles can be created for each team that would, for example, allow instructors to enter grades for all students but not to modify class schedules, while the other User Role would prevent schedulers from making changes to student performance data while still allowing them to make real-time changes to the class schedule.


## Data Partitioning

Organization A tracks the credentials for personnel employed with Organizations B, C, D, and E, who enter data for their personnel directly into Acadis. Data Partitioning allows Organizations B-E to see information about their respective personnel or their organization, but not others. Only Organization A would have access to all records.



## Multiple Academy Licenses

Organization X uses Acadis as their training and compliance solution, offering courses and certification programs to the entire student population. Organization Y supports the same, common student population, while providing a different set of training and compliance offerings than Organization X. Data Partitioning and multiple Academy licenses could be used together to allow all Acadis users from Organization X and Organization Y to provide their training and compliance offerings to the common student population, but maintain separate training content, courses, tests, and certification programs.
