A career in the fire service means regularly putting one's own physical and mental well-being at risk simply by performing the duties of the job. Fire leaders can help save lives and extend the careers of their members by implementing a reliable process to consistently track events and identify trends that impact wellness, such as:



Documenting combustible and bloodborne pathogen exposures



Identifying personnel in need of additional screenings due to carcinogenic exposures



Looping in peer support after a significant event / critical incident



Boosting morale with transparent positive recognition

Caring For Your Firefighters With Exposure Tracking

Cancer is a leading cause of death among firefighters. Multiple studies have demonstrated that firefighters are statistically at a higher risk for developing various types of cancer than the general population.

- Firefighters have a 9% higher risk of receiving a cancer diagnosis and are 14% more likely to die of cancer than the general U.S. population.
- In 2016, cancer caused 70% of line-of-duty deaths for career firefighters.
- In 2022, The World Health Organization's (WHO) International Agency for Research on Cancer (IARC) re-classified firefighter occupational exposure as a group 1 carcinogen.

Departments that consistently track exposures are better equipped to provide life-saving support to their members by identifying trends and documenting vital exposure details. They are also better equipped to provide documentation that protects the financial rights of their personnel and their families.



Protect Members Through Exposure Tracking and Proactive Health Screenings

From bodily fluids to hazardous materials to carcinogens, ensure your firefighters and EMS providers are protected with tracking that leads to better, proactive health screening.

- Flag at-risk members for increased screening when certain criteria are met.
- Document follow-up plans for next steps to keep everyone involved on the same page.
- Maintain a detailed log of on-the-job exposures when proof is required for workers' compensation, health care expenses, and/or pension rights.

Support Mental, Emotional, and Physical Wellness

The unique early intervention (EI) system identifies patterns of potential issues that may stem from significant events or critical incidents for timely follow-up by the most appropriate party.

- Customize categories, special fields, and set thresholds to alert personnel for intervention.
- Provide supervisors with insight into all incidents for a given time frame and quickly navigate to related events for a holistic view.
- Create reminders for significant event anniversaries to provide ongoing support and meaningful recognition to impacted parties.



Attract and Retain Personnel with Consistent Feedback and Positive Recognition

Transparent and consistent feedback and positive recognition from supervisors and peers boost morale, increase job satisfaction, and motivate members.

- Strengthen and unify crews with an easy process for documenting peer-to-peer recognition.
